Many Hands for Haiti is a 501(c)3 dedicated "To make God REAL for a broken world." We accomplish this by working with children, families, and communities in both Haiti and the US to unleash their God-given talents and resources to meet the challenges of the day.

Top 3 Program Services Accomplished:

1) Short-term experience trips: We believe we all are broken people, regardless if we live in Haiti or the US. We put significant effort in creating space for these two cultures to experience one another, allowing God to work through broken people for redemptive purposes. Each year, we send around 200 US volunteers into Haiti to work with our Haitian staff and communities. The relationships built are truly transformative, changing perceptions in both cultures and creating opportunities to become better people by working together. We fully coordinate these trips and ease the anxiety in traveling to a foreign culture. In 2014, we opened a new campus for short-term teams, including a new dormitory, fully equipped depot, clean water well, and proper security. The entire campus was built and is staffed completely by Haitians.

2) Educational programs: We seek to create a new path for our brothers and sisters in Haiti through education. In 2014, we funded four primary schools, giving the opportunity for 297 children to receive an education. In our Thrive for 5 program (ages 0-5), we performed weekly health education training to the mothers and fathers of our 138 children in the program. For adults, we operated an English class for doctors, nurses, and support staff whom regularly work with American medical personal. We also operated a sewing school for women, allowing 30 women to learn the

skills of sewing and cooking. These programs are primarily funded through scholarships.

3) Ethical feeding programs: Our feeding programs seek to meet the need for physical need for food regardless of race, gender, religion, or ethnic background. In 2014, we managed and/or provided over 1,200,000 meals in Haiti, including feeding programs at 12 schools, two orphanages, a hospital, 0-5 year old program, homeless and mentally disabled feeding, and numerous community feedings through churches or individual families. We especially targeted the most vulnerable in our feedings, such as young children, deaf children, homeless, elderly, and hospital patients.
